

## MTQG Stitches of Love Quilt Show Certified Quilt Appraiser

For Mountain Top Quilters Guild quilt show on May 29 & 30 at Findlay Toyota Center in Prescott Valley, we have secured an AQS certified quilt appraiser, Cindy Kurey, who is coming from Albuquerque. Online signups will be taken at the link below.

### **Why should I have my quilts appraised?**

1. To establish a replacement value for insurance purposes in the event of a loss due to fire, flood, or theft.
2. To meet your insurance company's requirements for a "Fine Art Floater."
3. To determine the value of your quilt for insurance coverage while at an exhibit or quilt competition.
4. To determine fair market value for the sale of a quilt.
5. To determine a value for donation gift or estate purposes (as required by the IRS).

### **Frequently Asked Questions**

**Q:** Are appraisals just for antique quilts?

**A:** Appraisals are for antique, vintage and newly made or contemporary quilts.

**Q:** What happens at an appraisal?

**A:** Appraisals require an in-person examination of the quilt which provides the basis for establishing the value of the quilt. A written formal report will be provided within several business days of the examination.

**Q:** What determines the value of a quilt?

**A:** A few of the factors that determine the value are condition, workmanship, size, age and provenance.

**Q:** Will a value be assessed to my quilt during a verbal consult?

**A:** No. Only written appraisals will receive a value assessed, which is more beneficial as it will cover your quilt for insurance purposes if it is lost or stolen.

**Q:** Can I have my quilt appraised if it is hanging in the show?

**A:** Yes! Cindy can accommodate appraisals for quilts that are hanging in the show.

**Q:** Can I have multiple quilts appraised?

**A:** Yes. Each appraisal should have its own time slot. So, if you have two quilts to appraise, select two time slots.

**Q:** When will I receive my written appraisal?

**A:** Cindy works on appraisals once she gets home. Please allow 2-3 weeks after the show to receive your written appraisal.

**Q:** How will my appraisal be sent to me?

**A:** The preference is to return appraisals via mail due to the pressurized seal that is applied to the appraisal (much like a notary creates an official stamp to a document). However, if requested they can be returned via email.

**Q:** How much does it cost?

**A:** Written appraisals are \$65 per quilt and verbal consultations are \$35 per quilt.

**Q:** How do I arrange for an appraisal or consultation?

**A:** 45-minute appointments are scheduled by going to [Quilt Appraisals/Consults](#). Walk-ins will also be available at the quilt show as the schedule allows.
